*Yard waste can only be put into a container that is used solely for yard waste; the reason being, yard waste has to be taken to a different dump site.

OUR TERMS ARE NET 30 DAYS AFTER RECEIPT OF INVOICE, PAST DUE THEREAFTER

A monthly finance charge, computed at a periodic rate of 1.5% per month to correspond to an annual percentage rate (APR) of 18% will be added to all past due accounts.

The amount of credit we extend to a customer is subject to change or limitation at any time. If a customer's account is past due, we shall have the right, in addition to all other legal remedies and without prejudice to any other of our rights, to defer further charges on account until payment is received.

This agreement shall remain in force until written notice of revocation by *Triangle Waste Services, Inc.*

- DO NOT OVERLOAD THE CONTAINER. WE MUST BE ABLE TO LOWER OUR TARP COMPLETELY OVER THE CONTAINER.
- DO NOT MIX YARD WASTE WITH CONSTRUCTION DEBRIS. WE HAVE TO CARRY THE YARD WASTE TO A DIFFERENT DUMP SITE THEREFORE, YARD WASTE IS NOT CHARGED BY THE TON, IT IS CHARGED BY THE LOAD.
- IF YOU ARE LOADING APPLIANCES, THEY MUST BE DRAINED OF ALL FLUIDS.
- WE CANNOT ACCEPT TIRES. THE LANDFILL CHARGES US A FEE FOR TIRES MIXED IN WITH OTHER DEBRIS, THEREFORE WE WILL PASS ON THE FEE TO YOU IF THERE ARE TIRES IN YOUR CONTAINER.
- PLEASE REMEMBER WHEN YOU ARE LOADING STONE, DIRT, BRICKS, ETC. THEY ARE HEAVIER THAN NORMAL CONSTRUCTION DEBRIS. THEREFORE, DO NOT LOAD THE CONTAINER MORE THAN HALF-WAY FULL. OUR TRUCK MUST MEET D.O.T. REGULATIONS WITH THE CONTAINER ON IT, THEREFORE WE CANNOT PULL A CONTAINER THAT IS OVERWEIGHT.

*****IF THE CONTAINER DOES NOT MEET THESE GUIDELINES, WE WILL NOT PICK IT UP UNTIL IT DOES AND YOU WILL BE CHARGED A \$65 NON-SERVICEABLE CONTAINER FEE.**
